Your Civil Service Council is pleased to provide you with a chance to go shopping without the hassle of driving. Transportation is being provided via charter bus to Woodfield Mall and IKEA in Schaumburg on Saturday, **December 5**.

Departure time from the Bone Student Center circle drive on the Illinois State University campus is set for 7:30 a.m. on Saturday, December 5. The group will arrive at Woodfield Mall around 10 a.m. An additional drop-off at IKEA will take place at 10:15 a.m.

A courtesy baggage pickup time at Woodfield has been arranged to stow packages under the bus at 2:30 p.m. The evening departure from IKEA is scheduled for 5 p.m. with pick up at Woodfield Mall at 5:15 p.m.

## DISTINGUISHED SERVICE AWARD

The Distinguished Service Award is the highest honor a staff member can receive at Illinois State University. In order to qualify for this award, nominees must be employed at the University for a minimum of five (5) years, and the same employee can only earn the award once every seven (7) years. Nominees are judged on three (3) criteria: outstanding job performance, campus-wide involvement, and community contributions. Award recipients will normally excel in all three areas. The award is based on significant contributions over a period of time and is not typically given for a single contribution. Recipients receive a \$500 cash award and a plaque. In addition, recipients' names are mounted on the University's Wall of Fame in the Bone Student Center.



The application as well as criteria information about the Distinguished Service Award can be found on the Civil Service Council's web site ([www.cscouncil.ilstu.edu/awards](http://www.cscouncil.ilstu.edu/awards)). Alternately, you may contact your dean, director, or department head, the Civil Service Council Chair, or any Civil Service Council member for a paper copy.

The application deadline is **December 1, 2009**. Award recipients will be announced during the Founders' Day Convocation in February.

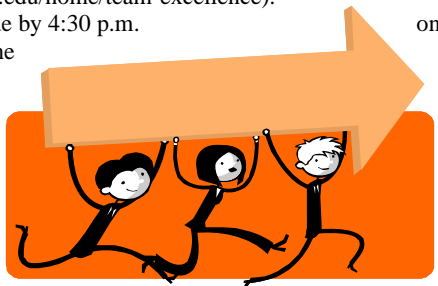
## 2010 TEAM EXCELLENCE AWARD
