## Call to Order

Vicechairperson Semlow called the meeting of the Academic Senate to order at 7:02 p.m. in the Circus Room of the Bone Student Center.

# Seating of New Senators

#### Roll Call

Secretary DeLong called the roll and declared a quorum present.

#### Approval of the Minutes of March 25, 1987

Mr. Gamsky wished to strike paragraph 5 on page 3, and replace with the following statement: "Mr. Gamsky replied that, in general, the fees at ISU were among the lowest in the State when compared with comparable institutions."

XVIII-59 Mr. Meiron moved to approve the minutes of March 25, 1987 as corrected (Second, Gamsky). Motion carried on a voice vote.

# Administrators' Remarks

President Watkins presented Certificates of Appreciation to Chairperson Len Schmaltz and Vice Chairperson Kevin Semlow, which read "Illinois State University awards this Certificate with sincere appreciation in recognition of a significant contribution to the university as Academic Senator and Chairperson/Vice Chairperson of the Academic Senate."

Mr. Watkins announced that Chancellor Rod Groves would be present on campus on Tuesday, April 28, 1987, at 4:00 p.m. in Hayden Auditorium, in Metcalf School. The purpose of his visit here is to attempt to give us a better picture of the budgeting situation in the State. It will be a good opportunity to hear about the complex process of budgeting. A number of people have made assumptions about the state budgeting process, the ability of any single institution or official to affect the process, and about how the process works or does not work. People make a number of generalizations and assumptions about the budget which are absolutely naive and incorrect. Chancellor Groves' visit is an opportunity to learn first hand about the budgeting process.

Mr. Watkins commented about the current uncertainty of the process of state budgeting and what has been happening in Springfield. He felt very uncertain about where things lie, and stated that there has been very little activity. Generally, by this time of year, there have at least been significant hearings before the Senate and the House. There have been none this year. The first hearing for ISU is scheduled before the Senate Appropriations Committee on the afternoon of Thursday, April 23. That is also the day the Board of Regents meets in Springfield. Thus far, the only hearings in higher education have been for the Board of Higher Education. He stated that he had also spoken with Phil Adams (BOR) and Sen. John Maitland, there was no news coming out of Springfield at this time. The mayoral election in Chicago had put a hold on everything. If there is no revenue enhancement (tax increase), things will be very hard indeed for everyone The service tax concept appears to be in trouble. Agency heads are doing the best that they can do, and University presidents are speaking up at every possible opportunity. The alternative could be a level budget year, which would mean the same operating budget that we have had.

Mr. Klass asked the President about the \$4.00 increase in the athletic fee and asked him to explain the reasons for this increase.

Mr. Watkins called on Susan Kern to speak to this matter. Susan Kern stated that the review process used to arrive at fee increases was a three-way decision. The Athletic Service Fee Advisory Board, the S.B.B.D., and Ms. Kern all submitted recommendations to the President. This year the Athletic Service Fee Advisory Board recommended a \$5.00 increase, the S.B.B.D. recommended \$4, and she recommended \$4.00. The President accepted the \$4.00 increase. The primary reasons for that recommendation were: (1) the fee has remained constant for the past three years, and has not been increased during that time period; (2) tuition and salary increases continue to go up. Over the last three years intercollegiate athletics has not bought any equipment. Insurance rates have also gone up.

Mr. Klass asked if it was true that even though the fee had remained constant, the enrollment at ISU has gone up and therefore, total revenues have increased.

Ms. Kern answered, Yes, it has increased some.

Mr. Klass asked if he could be assured that the monies derived from these fees would not be used to operate and furnish the new arena.

Ms. Kern said the equipment purchases included small pieces of equipment such as replacement of broken diving boards, etc., the Redbird mini-vans that were used by all the intercollegiate athletics.

Mr. Klass asked to be assured that this money would not go for the new arena. His concern was that the students were told that the \$35 arena fee would cover the building of the arena, and that it would be deceptive to have athletic fee increases finance the cost of equipment for the new arena.

Ms. Kern stated that the Athletic Fee covered operating expenses for the department of intercollegiate athletics. Pieces of equipment would be located wherever the athletics were housed. None of the money spent thus far had gone for the arena.

Provost Strand stated that the University had lost an esteemed colleague in the death of Sam Hutter, and he would ask Dr. Gamsky to comment on that.

Vice President for Student Affairs, Neal Gamsky, spoke about Dr. Sam Hutter, Psychology, who had passed away Sunday evening. Many senators had attended his funeral this afternoon. Ira Cohen had given one of the best eulogies for him. Sam had four loves in his life: tennis, family, books and teaching. He was the best-read individual that many had ever known. He had more information at his fingertips than most people had in the card catalog at the library. He often said that teaching was one of the best jobs in the world. He loved students, and never wanted to retire. We have lost a truly great scholar, excellent teacher, and a great friend of the University.

Vice President for Business and Finance Warren Harden had no comments.

Mr. Schmaltz thanked the Senate for their confidence. He made a few Chairperson's remarks. Committee Preference Sheets should be turned in right away. He had seen Chancellor Groves' presentation at the Board of Regents meeting, and thought it quite informative. Senators should avail themselves of this opportunity to see it on April 28th. He thanked Vice Chairperson Kevin Semlow for all his efforts during the past year. He had been extremely helpful and cooperative. He echoed Senator Gamsky's remarks, stating that Sam Hutter was a member of the Psychology Department. He was one of the first people that he met when he came here in 1974, and we have indeed lost a dear colleague, friend, and warm human being. The department of Psychology will never be the same again.
