CALL TO ORDER

Chairperson Len Schmaltz called the meeting of the Academic Senate to order at 7:04 p.m. in the Circus Room of the Bone Student Center.

ROLL CALL

Chairperson Schmaltz called the roll and declared a quorum present.

APPROVAL OF MINUTES OF APRIL 7, 1993

Senator Zeidenstein: I have two corrections. On the top of Page 12, second sentence should read: "It would be silly to say that a motion has to be put on the Senate Agenda....." On Page 17, first paragraph, fourteen lines down, should read: ".....as one non-lawyer to another non-lawyer," On line sixteen, delete the last three words of the sentence, ".....in passing it."

Senator Borg: On Page 31, third paragraph, second sentence should read: "They were made aware that students and faculty at the universities and on committees normally complete their business by the first week in May."

3. Approval of Academic Senate Internal Committee Assignments

XXIV-92

Motion to approve the slate of Academic Senate Internal Committee Assignments by White (Second, Johnson) carried on a voice vote.

Chairperson Schmaltz: I take full responsibility and blame for the faculty members' assignments. The Vice Chair handles the student assignments. Basically, decisions are made on seniority. If at all possible, I give faculty members in their third year their first choice. The other factor that comes in here is that on at least two committees there is tremendous interest from faculty to be on the Academic Affairs Committee and the Faculty Affairs Committee. Student Affairs Committee and Rules Committee do not receive as much interest. Tradition dictates that we try to have some collegiality on these committees with a representative from each college. That has to be mixed in with seniority. One senator did not get even his third choice, and was very gracious about agreeing to serve on another committee. Also, there are a great number of senators from Arts and Sciences, so some committees seem to be packed with Arts and Sciences senators.

Senator White: Is it a good idea to have all the faculty members from the Executive Committee on one committee, Faculty Affairs Committee.

Chairperson Schmaltz: They are not all on there -- four out of six. We do have a liaison with every committee except the Academic Affairs Committee. When I presented the committee assignments to the Executive Committee, the thought was that we would keep in close touch with the Academic Affairs Committee, even though we did not have a liaison. It is not a good idea, but those senators chose Faculty Affairs Committee, and three of them are third-year senators. Collegiality was also a concern. On Academic Affairs Committee, there is one senator who has been trying to get on that committee for three years. This is his third year.

Vice Chairperson Mousavi: For student senator assignments, a lot of senators got their second or third choices. It was hard to decide, because nine senators wanted the Student Affairs Committee. I think all the student senators got one of their three choices. I apologize if you did not get your first choice. If you have a big problem with your committee assignment, then you can speak with me after Senate.

Chairperson Schmaltz: If a senator wishes to speak with another senator on another committee and persuades them to switch committees, there is nothing in the Bylaws to forbid that. The Senate has to approve any changes.

COMMUNICATIONS

Senator Semlak: At the Executive Committee Meeting we discussed possible time lines for the disestablishment process. Could you describe the time lines.

Chairperson Schmaltz: That information is contained in the Executive Committee Minutes of which each senator receives a copy. On Page 3 of those minutes it reads: "A letter will be written to each committee regarding the program eliminations to be dealt with, and asking that a written recommendation be sent to the Academic Affairs Committee by noon, April 26, 1993."

Chairperson Schmaltz: Further down in the Executive Committee Minutes, it states: "The Senate will provide the President with its recommendation on programs to be eliminated by June 17, 1993 so that he can provide the Board of Regents with ISU's recommendations at their July meeting." This would be an information item at the May 5th Academic Senate Meeting, and an action item at the June 9, 1993 meeting of the Senate.

Senator Barker: I would like to inform senators that the bill to do away with the Board of Regents and establish a separate governing board for the three regency universities has just passed the state Senate, and is now in the House of Representatives. I would encourage senators to write to their representatives encouraging them to support the bill.
