1. Academic Plan 1995-2000 -- Sections I, II, and III

The Academic Plan is not approved by the Academic Senate. It is presented as an information item only.

Dr. Alan Dillingham, Associate Vice President for Instruction and Dean of Undergraduate Studies, presented the Academic Plan 1995-2000, Sections I, II, and III. In 1994 the Illinois Board of Higher Education reporting requirements were changed. A new format was established for organizing and submitting Academic Plans. Program Initiatives which were previously described in Section III are now included in the statement of priorities found in Section II. Section III contains the program reviews conducted according to the schedule set forth by the IBHE. Dr. Dillingham answered questions from the senators regarding the Academic Plan. The Plan will go through the Board of Regents to the IBHE.

Senator Weber proposed that the Executive Committee identify topics that need to be addressed in order to develop a detailed agenda for the Academic Senate for the coming year. After a brief discussion, Senator Schmaltz said the Executive Committee would discuss the proposal at its next meeting.
