Suggested Procedures

We suggest that the following calendar be presented to the Senate for the Fall semester with the scheduling of Spring semester topics by the Senate Executive Committee to follow the August 30th Senate meeting.

How would the Senate meetings work?

<u>Prior</u> to the Senate meeting when the topic is to come before the Senate for discussion the appropriate campus individuals would be invited to attend the assigned Senate meeting. The respective Senate Committees would investigate the status of the topic on campus through faculty and student input and be prepared to raise questions and lead discussion of the topic. All faculty, students, and administration are invited to attend the meetings.

During the Senate meeting the topic would come before the Senate as a discussion item (requiring no "information" or "action" stage consideration as does legislative and advisory items of regular Senate business). The Topic would be presented following the remarks of the Chairperson of the Senate and Administrator's Remarks but before the regular business of the Senate. A reasonable time (perhaps no more than one hour) will be devoted to the topic. The regular Senate rules of order and procedures are to be followed. Guests (faculty, students, and administrators) may speak to the issue and present concerns or information of value to the Senate. It is suggested that speakers notify the Senate office prior to the meeting. If time allows, all those who wish to speak will be given the opportunity to do so. Should time not be available yet further discussion on the topic evident and required, the issues will be sent to the approrpriate Senate Committee for further review. The deisgnated Senate Committee will then report back to the Senate at the subsequent meeting (during Committee Reports) the results of it's further discussion/review.

Announcements to the Faculty and Students should be made in advance so that the entire campus community knows what topics will be discussed and when. Additional topics could come from outside the Senate and should be directed to the Executive Committee of the Senate for consideration.

Call to Order

The meeting was called to order at 7:10 p.m. by Chair Len Schmaltz. Secretary Jan Cook called the roll and declared a quorum present.

Seating of New Senators

Senator Schmaltz introduced new senator Chuck Taylor, Interim Vice President for Business and Finance, and new student senator Eliazar Mendiola, Student Regent.

Approval of Minutes

Motion XXVII-1 to approve the Minutes of May 3, 1995 by Newby (second, Johnston) carried on a voice vote.

Chairperson's Remarks

Topics and Speakers for Senate Meetings: Chair Len Schmaltz presented a schedule of topics and speakers for the Fall 1995 Academic Senate meetings. The schedule was created by Senator Liedtke and Senator Nelsen in response to discussion of the proposal at the first Executive Committee meeting. The topics will not require action, but will be for information only. On the agenda, the topics will be scheduled after Administrators' Remarks. Senator Jagodzinksi suggested two revisions to the schedule: the corresponding Senate internal committee for the Academic Impact Fund should be Academic Affairs rather than Faculty Affairs; and the ASPT Process should be scheduled for discussion for the Fall semester instead of the Spring semester.

Summer Session Committee: Each of the chairs of the internal committees (except Rules) had been asked by Senator Schmaltz to appoint a member from his/her committee to serve on the committee to assess the Summer Session budget. The names were given to Provost Urice. Senator Urice said the Summer Session Committee was discussed at the Dean's Council meeting, and he will provide the Executive Committee with a list of his suggested members at the next Executive Committee meeting.

Academic Impact Fund Committee: The internal committee chairs (except for Rules Committee) had been asked by Senator Schmaltz to appoint a member of his/her committee to the Academic Impact Fund Committee. Those names have been provided to Provost Urice. Senator Urice said he plans to appoint two deans and a Provost Office liaison to the Committee as well.

Vice Chairperson's Remarks

Vice Chair Chris Harrison read a prepared statement in which he expressed concern over the proposal to replace the Academic Senate with a Faculty Senate, how this action would affect the students' involvement in shared governance, and the need for the students and faculty to work together.

Student Government Association President's Remarks

Student Government Association President Chris Jenkins read a prepared statement in which he said he was looking forward to a highly productive year in working with the faculty, student and administrative senators.

Administrators' Remarks

President David Strand stated he is looking forward to working with the Senate this year, a year which he has named "Operation Fresh Start." Members of the administration will be offering to meet with the Senate committees. Judith Riggs, Vice President for Institutional Advancement and Executive Director of the ISU Foundation, will be attending the Senate meetings; he will be asking the Senate to consider giving her position a seat on the Senate. These are some of the actions being taken to promote communication and shared governance. President Strand encouraged the Senate members to remember that providing the best education possible for students is the reason why we are all here, and the impacts of our actions on students must always be considered.

Provost Urice stated that he and Alan Dillingham, Associate Vice President for Instruction and Dean of Undergraduate Studies, will be meeting this week with the IBHE academic staff to discuss undergraduate instruction. He reported enrollment figures show that ISU has made progress in enrolling new students and is working towards increasing retention. He also stated that governance documents of other

universities are available for review in the Provost's Office, and that there will be no external search for the Associate Provost position this year.

Vice President Gurowitz said that the University received good reports from students and parents on Fall semester move-in and orientation. He also reported on campus housing and searches being conducted for vacancies in Student Affairs.

Vice President Taylor expressed appreciation for the opportunity to work with the Senate as interim Vice President for Business and Finance. He reported on the progress of the new science building and the University debit card.

 - Motion XXVII-4 by Senator Lessner (second, Johnston) to elect by acclamation Senator Petersen to the Honorary Degree Committee (nominated by Senator Harrison) carried on a voice vote.
- Action to elect two faculty senators to the Academic Planning Committee postponed until the September 13 Senate meeting.
- 4. Motion XXVII-5 by Senator Borg (second, Weber) to approve the Executive Committee and Academic Senate meeting schedule. Motion XXVII-6 by Senator Walker (second, Razaki) to move the December 4 Executive Committee meeting to November 27 and the December 13 Senate meeting to Thursday, December 7 carried on a voice vote. The main motion (XXVII-5) to approve the schedule, as amended, carried on a voice vote.

- Members of the committee to assess the Academic Impact Fund proposal were announced during the chairperson's remarks.
