Call to Order

The meeting was called to order at 7:07 p.m. by Chair, Jan Cook.

Roll Call

Senate Secretary Paul Borg called the roll and declared a quorum.

Approval of Minutes

The minutes of August 28, 1996 were corrected to include the Budget Committee's request that the Executive Committee forward records of interest to the chair, Senator Jones. Motion XXVIII-8 to approve corrected minutes of August 28, 1996, by Senator Varner (seconded by Malinsky) carried unanimously on a voice vote with no abstentions.

Chairperson's Remarks

Dean of Undergraduate Studies, Dr. Allan Dillingham will be meeting with the Executive Committee of the Senate on (Monday) Sept. 16 at 4:00 p.m., in Hovey 419. He will be briefing the Executive Committee on the various events that are planned by the Pilot Implementation Committee for the General Education Program during the fall semester. All people are allowed to attend. Please notify the Senate office of intention to attend, so we can hold the meeting in conference a room of appropriate size.

Vice Chairperson Matthew Malinsky announced at the August 28, 1996, meeting that he would be relinquishing his seat as ViceChair and return to the floor of the Senate effective at beginning of September 11, 1996 meeting. Students in tonight's caucus discussed the vice chairmanship as well as the Pilot General Education Program.

Vice Chairperson's Remarks

The newly elected Vice Chairman, Senator Joe Jannazzo reported the student caucus went very well. He plans to work hard with Saulter and the Student Government to make students more aware of the General Education Program, so they can judge for themselves.

He will work with Jan and the other Senators to have a good senate unity.

Student Government Association President's Remarks

Senator Saulter reported the caucus went very well. Students learned about the General Education Program from Dr. Urice and Dr. Dillingham. They explained the program so the students will be aware of the program and be a part of it. A major concern is for the students to get behind the program.

Administrators' Remarks:

President Strand

Last week the Board of Higher Education met at the University of Illinois, Urbana, Champaign. Among the action items was the approval of the HECA grants for the next fiscal year Illinois State University was the successful applicant for five of the grants totaling \$535,000. One grant has created the B/N Education Alliance which links District 87(Bloomington), Unit 5 (Normal), Heartland Community College & Illinois State University. This is a joint venture to try to enhance the type of programmatic exchanges which exist among these four education entities, and find ways in which Illinois State University, as the leader, can assist the others with their educational endeavors.

In past years, the schools programs have had specific types of cooperation. This new endeavor will be all encompassing. It will look at two models that exist elsewhere:

- 1. University of Southern Colorado, and the Pueblo School District.
- 2. Seattle, Washington between the Seattle Public Schools, Seattle Community College District and the University of Washington at Seattle.

While this is called an Educational Alliance, it does have the potential to involve all disciplines at the University. There will be a project team identified. Persons interested in participating should notify President Strand.

Provost Urice

Searches for Dean of the College of Business, Dean of University Libraries, and the Associate Provost all are being conducted under university procedures, with chairs from the Panel of Ten.

The "threshold events" in searches, such as interviews and other decision points, will be announced in an Illinois State University Report.

Tonight they received a report from Senator Taylor relative to the budget presentation he will make on Monday, September 16, at 9:00 a.m. to the Board of Trustees. The budget is an outcome of the budget process initiated in the spring. It is likely to have a good impact on FY98 budget.

Next meeting will be Wednesday, September 25, to hear a report by Senator Taylor on the budget discussion with the trustees.

<u>*Rules:*</u> Senator Nelsen, Chairperson, said the committee discussed procedures related to revision of Governance Documents. Committee meetings are scheduled at 6:00 p.m. on Senate meeting nights.

<u>Student Affairs:</u> Senator Robertson, Chairperson reminded members of a committee meeting at 9:00 p.m., September 11, after the Senate meeting. The remaining meetings of Student Affairs will be at 6:00 p.m. on Senate meeting nights.

Dean Sally Pancrazio was present to answer any questions. The motion carried unanimously on a voice vote with no abstentions.

Information Items:

- I. Senator Borg presented an MQM Proposal for a new sequence in Entreneurship and Small Business. Guest speaker, the chair of the department, Warren Nielsen and Lee Graf were at the table answer questions. Senator Jones stated that the Budget Committee agreed that the estimate of no new dollars was reasonable.
- II. In response to a question from Senator Schmaltz, Dr. Nielsen stated the enrollments have shifted in college business. The departments have been shifting to accommodate those enrollments and interests in students. Lower enrollment than in the past gives extra resources. Many students currently majoring in Business Administration, probably will move to the Entrepeneurship and Small Business Program.

Senator Borg presented the proposal to eliminate the Master of Arts in C&I. Dean Pancrazio was available to answer questions. They pointed out that no students are enrolled in the program at present.

Motion XXVIII-13 by Senator Borg (seconded by Lockwood) to move the elimination of Master of Arts in C&I to an action item. Chair Cook asked Dean Pancrazio if the College of Education had any objection to this motion. She had none. The motion carried unanimously on a voice vote with no abstentions.

Motion XXVIII-14 by Senator Borg (seconded by Amstadt) to eliminate the Master of Arts in C&I. The motion carried unanimously on a voice vote with no abstentions.

III. Senator Nelsen presented the proposed By-Laws and the Milner Library Faculty Council. Librarians George Palmer and Vanette Schwartz were able to answer questions

Senator Razaki again volunteered to answer questions about his report on the last meeting of the Illinois State University Foundation Board. Senator Jones asked how the board received faculty and student input on use of funds. Senator Razaki said that discussions with President Strand were continuing on that point.
