APPROVAL OF MINUTES

After the meeting was called to order, Mr. Gillett moved that the minutes of the meeting of December 16, 1965 be approved as distributed. Mr. Bone seconded the motion, which passed by voice vote.

ADMINISTRATIVE REORGANIZATION

Mr. Harden noted the receipt of communications concerning reorganization from Miss Kelly; Messrs. Toll, Rye, Spector, and Prince; the Department of Health and Physical Education for Women, the Department of Health and Physical Education for Men; and 138 signatories of a petition concerning reorganization.

Mr. Bone moved that the motion concerning reorganization tabled at the meeting of December 16, 1965 be removed from the table. Miss Speer seconded the motion, which passed by voice vote. Mr. Sweet then withdrew the motion, and Mr. Smith his second. The floor being open for discussion, Mr. White presented the results of the faculty seminars.

Mr. Ledbetter moved that that part of the minority report establishing three colleges effective Fall, 1966, (without commitment to establishment or placement of departments within them) be approved, with other colleges to be established as soon as practicable. ELECTIONS

Mr. Gillett reported for the Elections Committee. Mr. Gillett moved that the Council accept the petition of those wishing their names deleted from the ballot for the Council. Mr. Dillinger seconded the motion, which passed by voice vote.

SPEAKERS POLICY

Mr. Smith reported for the Committee on the Policy for Speakers. Mr. Sweet moved that action on the report be delayed until the February meeting. Mr. Shuman seconded the motion, which passed by voice vote.

UNIVERSITY COUNCIL AWARDS

Mr. Bishop reported for the committee on University Council Awards. Mr. Bishop moved that the University Council make two awards of \$300 each, to be acknowledged on the June commencement program. Applications for the awards will be received from the students themselves. The application should consist of an essay of no more than 2,000 words describing and documenting some creative activity in which the student has made a significant contribution.

The essays will be submitted to a committee appointed by the University Council for judgment. They will be evaluated, not for their literary merit, but for the probable significance of the student's contribution in his field. Weight will be given to the significance of the problem attempted, the means employed in its solution, and the probable benefits to be expected from the student's work. Mr. Ledbetter seconded the motion, which passed by voice vote.

ELECTIONS

An election for two members of a committee to select a Head for the Department of Health and Physical Education for Men was held. Mr. Legg and Mr. Sweet were chosen.

An election for a member of the Faculty Advisory Committee for the Board for Higher Education was held. Mr. Harden was chosen.

RETIREMENT RECOGNITION

Mr. Bone moved that the Committee to choose a suitable means of recognizing retired faculty be empowered to proceed. Mr. Shuman seconded the motion, which passed unanimously.

ADJOURNMENT

Mr. Legg moved that the Council adjourn. Mr. Dillinger seconded the motion, which passed unanimously.
