APPROVAL OF MINUTES

Mr. White moved that the minutes of the January meeting be approved. The motion was seconded by Mr. Gilmore and carried.

CLASS WITHDRAWALS DURING THE SEMESTER

A communication was received from Miss Ellen Kelly which raised several questions concerning student withdrawals from courses late in the semester. One question refers specifically to the policy of permitting students to remove D's by repeating courses and substituting a higher grade. Another question raised concerned the merit of tightening up the present ruling with regard to withdrawing from courses with a passing grade. The communication was reviewed and discussed.

A motion was made by Miss Russell and seconded by Mr. Helgeson that this problem be referred to the Academic Standards Committee for study and consideration. The motion carried. The Committee will bring their recommendations back to the University Council.
