PROGRESS REPORT OF THE COMMITTEE ON PROGRAM EXPANSION

After prefatory remarks by President Bone on the routing of the report of the Committee on Program Expansion, this document, entitled Expansion of Purpose, was discussed at some length. It was agreed that it would be distributed with the minutes to the faculty. It was moved by Mr. Prince and seconded by Mr. Smith that the report be accepted. The motion carried unanimously.

JOINT FACULTY POLICY COMMITTEE

After discussion of the minutes of the meeting of the Joint Faculty Policy Committee of February 9, 1965, it was agreed that the report of the Committee would be distributed to the faculty with the minutes of the Council meeting.

COMMUNICATIONS

President Bone called for a discussion of the problem of the determination of faculty merit. After discussion, it was suggested that the issue might be made the subject of a series of faculty seminars like those conducted last spring. It was agreed to place the matter on the agenda for the next meeting.

It was moved by Miss Speer and seconded by Mr. Legg that the Executive Committee of the Council appoint a committee of two or three to send a resolution of thanks to Mr. Stipes, retiring chairman of the Teachers College Board. The motion was passed without dissent.

After a discussion of the problem of appointing members to the building committees, Mr. Legg moved and Mr. Trotter seconded that the Executive Committee of the Council be requested to make appointment to fill the vacancies on those committees. The motion carried unanimously.

There was some discussion of the problem of student admissions. It was suggested that admission to certain departments might be carried on after a certain cutoff point for the University as a whole.

The motion was made by Mr. White and seconded by Mr. Legg that the meeting be adjourned. The motion carried.
